You should ensure the immediate safety of all individuals.

You should complete an electronic Incident Report (MIS Engage) and inform a DSL or DDSL. If you do not have access to MIS Engage complete a Cause for Childrens Welfare Form and hand to the DSL or DDSL (forms in office)

You should follow the Procedures for referral that have been agreed with the local Safeguarding Children Team which can be found on the Safeguarding notice board in reception at site.

Follow the criteria and paperwork for referral as approved by your local Safeguarding Children Team by submitting a Multi Agency referral Form to the appropriate Local Authority — Leicestershire is home authority <u>Multi-Agency Referral Form for Early Help and Social Care services (MARF) | Leicestershire County Council Professional Services Portal</u>
